In pursuance of the approval of names by the D.P.C., constituted in the reference fourth read above, and under Rule.10 (a) of the A.P. State and Subordinate Services Rules 1996, the Junior Lecturers whose names are shown in the Annexure to these proceedings are temporarily appointed as Lecturers in **Chemistry** and posted to the Colleges noted against their names. These orders of appointment are issued subject to the result of O.A.No.5285/2003 filed by Sri. K. Kumara Swamy, and 11 others which is pending before the A.P.A.T. and in terms of the orders dated 11.8.2003 of the Tribunal in the O.A. and also subject to the result of any other O.A.s pending before the Hon'ble APAT, Hyderabad.

They are informed that as per the Government orders issued in the reference fifth read above, the Junior Lecturers appointed prior to 1.1.1986 and promoted as Lecturers at any time after issue of G.O.Ms.No.61, Edn., dated 16.7.2001, shall be deemed to have been exempted from passing NET/SLET and from possessing 55% of marks in P.G. Degree to become eligible for U.G.C. Pay Scales. Further, the Junior Lecturers appointed after 1.1.1986 and promoted now as Lecturers have to pass NET/SLET and possess 55% of marks in P.G. Degree to become eligible for of UGC pay scales of 1996. However, they are eligible for State revised pay scales in the cadre of Lecturers.

They are informed that their services as Lecturers are liable to be terminated at any time without notice and without assigning any reason what so ever for such termination. They are also informed that their appointment as Lecturers is ordered

without prejudice to the claims of other senior lecturers, if any, in the subject in the

In the G.O. third read above, Government have directed that recruitment to the posts of Physical Directors in Degree Colleges shall be made as per the existing rules which provide for promotion of Physical Directors in Junior Colleges to Physical Directors in Degree Colleges after exhausting the Assistant Physical Directors in Degree Colleges. Promotion to the posts of the Physical Directors in Degree Colleges shall be made on the basis of seniority-cum-fitness and applicability of the Scale of Pay to the promotees (i.e., UGC or State Scale) shall be determined depending on his/her qualifications.

In pursuance of the approval of the names by the Departmental Promotion Committee in the meeting held on 06-10-2004 and under Rule 10 (a) of the General Rules for the A.P. State and Subordinate Services Rules, 1996, the Physical Directors-Grade.II working in Government Junior Colleges whose names are shown in the Annexure to these proceedings, are hereby temporarily appointed (promoted) as Physical Directors of Degree Colleges (Category-I of Class.IV of APSS) and posted to the colleges noted against their names in Zone.IV, in the Scale of Pay of Rs.6950-200-7150-250-8400-300-9900-350-11650-450-13900-525-14425 (Revised Pay Scales, 1998).
