

HISTORY OF THE COLLEGE

The college was established in August, 1988. In the beginning B.A. with History, 1988. In the beginning B.A. with History, Economics and Political Science and B.Com, General Courses in Telugu Medium were started. Then Restructured Courses in Science namely, B.Sc. (Maths, Physics and Computer Science) and B.Sc., (Microbiology, Biochemistry and Chemistry) and B.Com. C.A. in English Medium were started in 1998-99. The College has a strength of 493 students at present. Permission has been accorded to start a P.G. Course in M.A. (History) during 2005-06. In 2009-2010 B.A. (H.E.CA) Group was also introduced in the college.

The college was shifted from PVC Govt. Junior College campus to the present buildings in August, 2000, located on the Tirupati-Madanapaile Road 4.51 acres at the entrance of Valmikipuram.

A definiter concept of 'social movement' is a deliberate collective endeavor to promote direction by means of excluding violence, illegality, revolution or withdrawal, etc., and hence clearly symbolize a difference from historical movements, tendencies or trends, etc. Hence, a social mobility and change brought by 'social movement' based on challenge, protest, confrontation, aggression and revolt as opposed to acquiescence, request, obedience, loyalty, etc. and more recently these are classified into several categories on the basis of participants, i.e., peasants, tribals, students, women, dalits, etc. In many cases the participants and issues go together in order to synthesize the objectives and aims of the present seminar topic with a view to get full and satisfied information which is historically embedded within the society in and around the present Rayalaseema Region of Andhra Pradesh as a whole and at a regional level or micro-level in particular.

As we know that the present Andhra society that exists now (excluding the post-bifurcated Telangana) has a vast historical back ground right from the annals of historical significance since 600 BC., till Modern times and it possesses all characteristic features of Indian society with social strata(hierarchical forward castes, backward classes, scheduled castes and scheduled tribes, etc) with different socio-economic and cultural features. The present Andhra Pradesh, after bifurcation, comprised the geographical area namely Rayalaseema consists of districts of Anantapur, Kadapa, Kurnool, and Chittoor which lies in the south-western part of the state comprised different natural resources, drainage system, forests, weather conditions, food habits, behavior, way of life, etc., but people speak a common language and other common important socio-cultural aspects. However, the changes that occurred in the Andhra society might have been the results of protests against the functions of past system through the governments or public by the inspiration of other areas of our country as a whole and at a regional level or micro-level.
